I wanted to share with you some actions and resources for residents of our South Bay area to get information on the State's Covid-19 pandemic response.

Fed update:

The Federal Government passed two measures in the last two weeks designed to aid those affected by the Covid-19 pandemic.

Whether you are employed full time or part time, a gig worker, unemployed, or retired, you may be eligible for a stimulus payment. To see if you qualify for a stimulus payment:

State update:

**Rent:** Last week, Governor Newsom signed an Executive Order which "prohibits landlords from evicting tenants for nonpayment of rent and prohibits enforcement of evictions by law enforcement or courts." Mortgages: Additionally, the Governor announced an agreement with over 30 lending institutions who are extending mortgage relief for 90 days.
